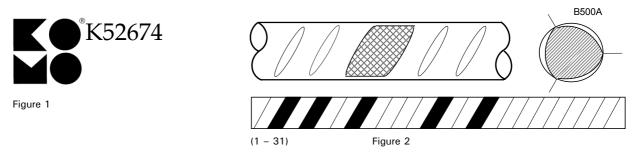

Place of the mark: on a mutual distance of \pm 0,50 meter. The position of the transverse ribs may also be in reverse.
